Description

Course Description: This course is open only to students taking the CPA Review Package. It covers the knowledge and understanding of the financial reporting framework used by businesses, not-for-profit, and government entities. The financial reporting frameworks covered in this course include those issued by the FASB, the IASB, the SEC, and the GASB. (Prerequisite: ACCT601)

Course Scope:

The course is designed for students who have a solid understanding of generally accepted accounting principles and are interested in pursuing a career in accounting such as auditing, taxation, management consultancy, financial accounting, cost accounting, government accounting, and more. This includes students interested in sitting for the Certified Public Accountant Exam.
