Description

Course Description: This course is open only to students taking the CPA Review Package. It covers the knowledge and understanding of professional and legal responsibilities of CPAs. These include the professional ethics issues relating to tax practices and based on the AICPA Code of Professional Conduct, Treasury Department Circular 230, and rules and regulations for tax return preparers. Business law topics covered include the legal implications of business transactions, auditing, and financial reporting. reporting. (Prerequisite: ACCT616)
