Description

Course Description: A study of the techniques used to interpret and analyze financial statements effectively. Managers, accountants, investors and analysts often perform analytical procedure to learn more about what is being reported by public corporations. The viewpoint is that of the user of financial statements. This course is designed primarily for students who expect to be intensive users of financial statements as part of their professional responsibilities. Students must have access to Microsoft Word and Microsoft Excel software.

Course Scope:

Students will explore advanced components of financial statement analysis. The course reviews the elements of the income statement, balance sheet and statement of cash flows to calculate various financial ratios used in financial analysis and reporting. It also covers the perspective from users of financial reporting and among specialized industries.
