In this course students will assess the different legal frameworks used to combat human trafficking around the world and analyze the different discourses used to discuss the trafficking phenomena. Students will learn important terminology in this field, the different types of human trafficking that exist and an understanding of the scope of the problem, both domestically and globally. ## Evaluation Procedures

Your final grade in this course will be based on the following course requirements:

- 1. Introduction Assignment:** Each student will be required to post a personal introduction in the discussion forums and respond to at least two others introduction post. Students must have three posting as a minimum to successfully complete this assignment. The Introduction Assignment is due by the end of week 1.
- 2. Weekly Forum Questions and Responses Assignment:** Each student will be required to post and stay active in the weekly forum questions and response. There will be a total of 8 graded weekly forum assignments that will require the students to post an original response of at least 500 words with two scholarly supporting references, one must come from the online library or class material, and be a peer-reviewed journal article in APA Style. Each student will then make two additional postings of at least 250 words for each posting. To have successfully complete the weekly forum assignment students need to have a minimum of three postings. Based on the rubric, you must also post to the professor. Forum postings will be graded using the forums writing rubric located in the lessons section. The first original posting is due by Thursday of the assignment week, and the two follow up postings are due by Sunday of the same week.
- 3. Annotated Bibliography Assignment:** Each student will be required to write an APA Style annotated bibliography. The scholarly references selected by the student will be peer-reviewed journal articles retrieved from the APUS Online Library databases or Human Trafficking Articles in the lessons. The student must select four (4) peer-reviewed journal articles, analysis these articles and give a brief 250 word analysis for each references selected. The annotated bibliography is located in the assignment section of the class we detailed instructions on how to successfully complete this assignment, and this assignment is due by the end of week 4. There is a sample Annotated Bibliography APA Style paper located in the assignment section for the student to use as a template. There is also additional annotated bibliography information in the APA Style assignment section of the class.
- 4. Power Point Project (PPP) Assignment:** Each student will be required to create a 12 slide Power Point Assignment not including a Cover Page or the Reference Page. Students will be required to submit/upload their PPP to the assignment section for grading by Thursday of week 6. Students will also upload their PPP as an attachment to the Week 6 Weekly Forum original posting with a brief introduction. Students will then be required to answer questions on their PPP by the class instructor and entire class. Students must demonstrate good critical thinking, become the subject matter expert

on their PPP information, and stay active answering and teaching from their PPP. Failure to stay active or respond in detail will result in a zero grade for participation on this assignment. There will be a detail assignment rubric posted with the assignment instructions. The students PPP must be posted to the Week 6 Forum by Thursday, and the follow-up questions and answers must be posted by Sunday of week 6.

- 5. Term Project Assignment:** Each student will be required to complete the term project, which is a 1200-word APA Style paper. The project should have 1200-words of substance not counting the cover and reference page. The Term Project must be in a Word Document (.doc) uploaded to the assignment. Students will be required to use three scholarly references, and two of these references must be peer-reviewed journal articles that come from the APUS online library databases. The Term Project is due by the end of week 7.

upload and check suspicious papers, without requiring student to create their own Turnitin.com profiles.

Turnitin.com analyzes electronic submissions of student writing, compares them to the contents of a huge online database, and generates a customized Originality Report. The database used to produce this analysis contains a massive collection of documents available on the Internet from both free and commercial sources, as well as the full texts of all other papers that have been previously submitted to Turnitin.com.
