Course Description (Catalog)

Community and Public Health Nurses practicing at an advanced level must possess the knowledge and skills necessary to improve the health of communities and populations. Students will build on their previous knowledge and learn to design public health programs to improve health outcomes. Topics include assessing community and public health needs along with planning programs to meet those needs. Students work with the Practicum Coordinator and faculty to identify a qualified preceptor and to select a practicum site. Students will complete 40 of the 160 hours of clinical practice required for completion of the program.

Course Scope

This course is divided into 8 weeks and is designed to provide the learner with key concepts of community and public health nursing required for developing and evaluating programs to improve the health of communities and populations. Learners will identify a public health need and develop a program plan to meet that need. Learners will complete 40 hours of supervised clinical practice designed to enhance the development of community and public health programs.

Course Learning Objectives

- 1. Describe the impact of social, behavioral, environmental, and biological factors on the health of communities and populations. (PO 1,4)
- 2. Evaluate the role of the public health nurse in meeting healthcare needs of communities and populations. (PO 2,8)

- 4. Identify local health care policies to evaluate a need for revisions or development of a new policy to improve community health outcomes. (PO 3, 6)
- 5. Develop a program evaluation plan for a proposed community program. (PO 2,4)
- 6. Analyze available financial resources for a community health program proposal. (PO 2, 5, 6)
- 7. Collaborate with community stakeholders to develop a community program to improve health outcomes. (PO 2, 7)

Course Delivery Method

This course delivered via distance learning will enable students to complete academic work in a flexible manner, completely online. Course materials and access to MyClassroom will be made available to each student. Online assignments are due weekly as noted on the course outline and can include Discussions questions and written assignments. Assigned faculty will support the students throughout this eight-week course.

Evaluation Procedures

Discussions

Please join the discussions each week. Replies must be posted in the week due and replies after the end of the each week will not be graded. The Discussions are for student interaction and input should be submitted before the week ends in order to fully participate in the discussions. Students should demonstrate their own knowledge in the discussions and avoid copying and pasting from websites. In this class there are 6 graded discussions.

Guidelines:

- Post the initial response to each discussions by 11:55pm, ET, Wednesday
- Initial responses are to be original in content and demonstrate a thorough analysis of the topic.
- Reply to more than two of your classmates in each discussions by 11:55pm, ET, Sunday for full participation credit.
- Responses to classmates are significant to advance the discussions.
- All discussions can be accessed in the Discussions section of the course.
- Respond to all questions posed to you in your initial post by instructor and/or peers.

An initial post must precede the response posts to peers. An initial post received after Wednesday 11:55 pm will receive a 10% deduction for each day, for 3 days, prior to discussions being graded. This means the highest grade possible for a late submission of 3 days, is 70%. However, response posts are due by Sunday 11:55 pm. If response posts are not submitted by this time, the discussion is over. Therefore, no points can be awarded for collaboration, and the highest grade possible for late submission past 3 days is 60%.

Nursing Program Policies

Assignment and Coursework Grading Policy

Students are expected to submit classroom assignments by the designated due date and to complete the course according to the published class schedule. Failure to submit coursework by the designated due date will result in a ten percent (10%) penalty per day until three (3) days after the coursework is due. Therefore, after three (3) days, the maximum grade the student can achieve with a late submission will be a grade of 70% (C-).
